State Reimbursements

- **State Judges Supplement** [MCL 600.8202](#)
 - The state is required to reimburse the district funding unit or units the amount that the unit or units have paid to the judge.
 - \$45,744/judge in 2017.
- **Juror Compensation Reimbursement Fund**
[MCL 600.151d](#)
 - Reimbursement for mileage and attendance rates paid to jurors.
 - Funded from driver license clearance fees (\$45). [MCL 257.321a](#)
 - \$15 Secretary of State; \$15 Funding Unit; \$15 Juror Compensation Fund
 - Funded from Jury Demand Fees (\$50) [MCL 600.8371](#)
 - \$40 funding unit; \$10 Juror Compensation Fund
 - Funded by investment income credited to the fund by the state treasurer..

State Reimbursements

- Drunk Driving Caseflow Assistance Fund

[MCL 257.625h](#)

- Promote the timely disposition of drunk driving cases.
- Funded from the collection of revenue from \$125 license reinstatement fees [MCL 257.320e\(1\)](#)
 - \$85 Department of State;
 - \$30 Drunk Driving Assistance Fund;
 - \$10 Drunk Driving Prevention Fund.
- Funded by investment income credited to the fund by the state treasurer.
- The state court administrator distributes monies from the funds annually to district and municipal courts.

State Reimbursements

- Drug Case Info Management Fund [MCL 257.323d](#)
 - Promote the timely management and reporting of drug convictions to the Secretary of State.
 - Funded from the collection of revenue from license reinstatement fees (\$125). [MCL 257.320e\(3\)](#)
 - \$95 Department of State;
 - \$30 Drug Case Management Fund
 - The state court administrator distributes monies from the funds annually to district and municipal courts.

SCAO Grants

- **State Court Administrative Office(SCAO) Office of Highway Safety Planning (OHSP)**
 - SCAO provides funding assistance for planning and implementation grants for new or expanding driving while intoxicated (DWI) treatment courts
- **Federal Office of Highway Safety Planning Regional DWI Regional Court Grant Program**
 - SCAO Provides funding assistance for planning and implementation grants for new and expanding Regional Driving While Intoxicated (RDWI) courts.
- **Michigan Drug Court Grant Program**
 - SCAO provides funding assistance for drug courts through its Michigan Drug Court Grant Program. Adult, juvenile, family dependency, and DWI (focused on drunken driving cases) are eligible to receive funding from the MDCGP.

 - SCAO provides funding assistance for the planning and operation of mental health courts.

 - SCAO provides funding assistance for courts that are interested in establishing a new mental health court and are in the early stages of planning.

 - SCAO provides funding assistance for regional mental health courts that have completed the planning phase or are fully operational.

Fines

- Statute Fines
 - Imposed for a penal law violation of the state or a civil infraction violation of the state.
 - Penal Fines
 - Civil Fines
- Ordinance Fines
 - Imposed for a violation of a municipality's ordinance.

Statute Fines

100% of a statute fine is distributed to support of public libraries

[Michigan Constitution of 1963, Article 8, Section 9. MCL 600.9379\(1\)\(a\); 600.8831; 257.909\(1\)](#)

- Penal Fines - Criminal Misdemeanor & Traffic Misdemeanor

- Criminal misdemeanor penal fine is discretionary, unless a minimum fine is set forth by specific statute.
- Traffic misdemeanor penal fine is discretionary with a \$100 maximum, unless otherwise set forth specific statute law. [MCL 257.901\(2\)](#)

- Civil Fines - Traffic Civil Infractions & State Civil Infractions

- Traffic civil infraction fine is discretionary with a \$100 maximum unless otherwise set forth by law. [MCL 257.907\(2\)](#)
- Traffic civil infraction fine is doubled for a traffic violation in a work zone, school zone, school bus zone, or emergency scene. [MCL 257.601b\(1\)](#)

Ordinance Fines

1/3 of the fine is distributed to the political subdivision whose ordinance was violated. The remaining 2/3 of the fine is retained by the court's funding unit. [MCL 600.8379](#)

- EXCEPTION: Commercial Motor Vehicle – 70% of the fine is distributed to the political subdivision whose ordinance was violated. The remaining 30% is distributed to public library system. [MCL 257.909\(1\)](#)
- Ordinance Misdemeanors
 - Fine is discretionary with a \$500 maximum, unless otherwise set forth by law. [MCL 41.183\(5\)](#); [46.10b\(5\)](#); [66.2\(50\)](#); [117.3\(k\)](#)
 - Traffic misdemeanor fine is discretionary with a \$100 maximum, unless otherwise set forth specific statute law. [MCL 257.901\(2\)](#)
- Ordinance Civil Infraction & Municipal Civil Infraction
 - Traffic civil infraction fine is discretionary with a \$100 maximum unless otherwise set forth by law [MCL 257.907\(2\)](#)
 - Traffic civil infraction fine is doubled for a traffic violation in a work zone, school zone, school bus zone, or emergency scene. [MCL 257.601b\(1\)](#)

Costs (Court Costs) [MCL 769.1K](#)

- Any costs authorized by statute.
- Any cost reasonably related to the actual costs incurred by the trial court without separately calculating those costs involved in the particular case, including, but not limited to, the following:
 - Salaries and benefits for relevant court personnel.
 - Goods and services necessary for the operation of the court.
 - Necessary expenses for the operation and maintenance of court buildings and facilities.

Costs (Court Costs) [MCL 769.1K](#)

- Statute violations - distributed to the court's funding unit. [MCL 600.8379\(1\)\(b\)](#)
- Ordinance violations - distributed: [MCL 600.8379 \(1\)\(c\)](#)
 - 1/3 of costs - distributed to the political subdivision whose ordinance was violated.
 - 2/3 of costs - retained by the court's funding unit.
- Costs for traffic civil infractions are discretionary with a maximum of \$100, unless otherwise set forth by statute. [MCL 257.907\(4\)](#)
- Costs for state civil Infractions are discretionary with a maximum of \$500. [MCL 600.8827\(3\)](#)
- Costs for municipal civil infractions are discretionary with a maximum of \$500. [MCL 600.8727\(3\)](#)

Costs (State Costs) [MCL 769.1j\(1\)\(b\)](#); [769.1k\(1\)\(b\)](#)

- Minimum State Cost
 - \$50 – All misdemeanor convictions, including traffic misdemeanors [MCL 769.1j\(1\)\(b\)](#)
- Justice System Assessment
 - \$40 – All traffic civil infractions [MCL 257.907\(13\)](#); [MCL 600.8381\(5\)](#)
 - \$10 – All nontraffic civil infractions [MCL 600.8381\(5\)](#)
 - State civil Infraction [MCL 600.8827\(4\)](#)
 - Municipal Civil infraction [MCL 600.8727\(4\)](#)
- 100% distributed to the State of Michigan

Justice System Fund [MCL 600.181](#)

Funded by the collection of revenue from court assessments and costs designated by law for deposit in the fund and by investment income credited to the fund by the state treasurer.

Costs ordered for reimbursement to the state or a local unit of government for expenses incurred in relation to the incident that resulted in a conviction, including, but not limited to, expenses for an emergency response and expenses for prosecuting the person.

Assessment authorized by statute for a specific purpose.

- **Crime Victim Rights Fund** [MCL 780.905](#)
 - \$75 Assessment on all misdemeanor convictions
 - One assessment per case
 - Fee cannot be waived
 - Disbursement - 90% (State Treasury) & 10% (local funding unit)
- **Drivers License Clearance Fee** [MCL 257.321a](#)
 - \$45 fee to clear driver's license suspension for failure to appear in court (FAC) or Failure to Pay fines and costs (FCJ)
 - Disbursement to:
 - Local funding unit - \$15
 - State of Michigan
 - \$15 Juror Compensation Fund
 - \$15 Secretary of State

Fees & Assessments

- Conservation Violation Fees

- \$10 - DNR Judgment Fee (all game and fish violations)[MCL 324.1609](#)
 - Distributed to the State of Michigan - Michigan Fish and Game Protection Fund
- DNR Reimbursement fee (illegal possessing, selling, purchasing or killing of game, protected animals, or fish) [MCL 324.40119](#); [MCL 324.48740](#)
 - Fee varies by animal/fish
 - Distributed to the State of Michigan game and fish protection account of the Michigan Conservation and Recreation Legacy Fund

- 20% Late Fee [MCL 600.4803](#)

- 20% fee imposed on the balance of any misdemeanor or civil infraction case which has aged 56 days.
- 100% retained by the local funding unit.

 - Fee for providing legal assistance to the defendant.
 - Discretionary; distributed to local funding unit.
- **Cost to Compel Appearance**

 - Reimbursement for any additional costs incurred in compelling the defendant's appearance.
 - Bench Warrant Fee;
 - Show Cause Fee;
 - Default judgment Fee.
 - Discretionary; distributed to local funding unit.
- **Drug Court Participation Fee** [MCL 600.1070\(4\)](#)
 - Fee assessed for participation in a Drug Court Program
 - Reasonably related to cost of program; distributed to local funding unit.

Fees & Assessments

- DNA Assessment [MCL 28.176\(5\)](#)
 - \$60 fee for DNA identification sample
 - Specific misdemeanors only.
 - Distributed to:
 - 65% to State of Michigan - Justice System Fund
 - 25% to the law enforcement agency that collected the sample
 - 10% to local funding unit
- No Proof of Insurance Fee MCL [257.328\(3\)\(c\)](#)
 - \$25 fee assessed if the defendant submits proof to the court that the motor vehicle had insurance at the time the violation occurred.
 - No other fines and costs may be assessed.
 - Distributed to local funding unit.

Fees & Assessments

Probation Fees [MCL 771.3](#)

- **Oversight Fee**

- \$35/month supervision and monitoring fee assessed to defendants on probation.
 - Discretionary; set by the court.
 - Distributed to the local funding unit.

- **Screening & Assessment Fee**

- \$75 fee assessed for a substance abuse assessment conducted by the probation department
 - Discretionary; set by the court.
 - Distributed to the local funding unit.

- **Presentence Investigation Fee**

- \$100 fee assessed for the completion of a presentence report.
 - Discretionary; set by the court.
 - Distributed to the local funding unit..

Restitution [MCL 769.1a\(2\)](#); [MCL 769.3](#); [MCL 771.3\(1\)\(e\)](#) [MCL 780.826\(2\)](#)

Defendant is ordered to make full restitution to any victim of the defendant's course of conduct that gives rise to the conviction or to the victim's estate.

- Money is held in escrow by the court.
- Payable to:
 - Victim
 - Victim's estate
 - Crime Victim Rights Fund if victim cannot be located or refuses to claim restitution

Total Assessment = \$120

 - In every criminal or civil appeal from district court the appellant must pay an \$25 appeal fee.
 - Distributed to local funding unit.

 - \$10 fee for wedding ceremonies performed by district judge/magistrate.
 - Distributed to local funding unit
